WHAT IS "INFORMED CONSENT" and WHY DOES IT MATTER? Participants in this training will learn about the importance of disclosing to participants, at intake, the following: An SUD Diagnosis; the full Continuum of Care (Inpatient, Residential, Intensive Outpatient, Outpatient, Recovery Support Services and Withdrawal Management Services); the definition and application of "Medical Necessity" as it relates to placement, duration of care and transitioning through multiple levels of care; the different modalities of Treatment; the availability and viability of Medication Assisted Treatment (MAT); the availability of Culturally and Linguistically Appropriate Services; the funding sources for treatment; L.A. County's Patient Handbook; Privacy and Patient Confidentiality; Program Rules and grounds for discharge from treatment; and the importance of patient preference and patient-centered treatment.

This training includes a review of Los Angeles County's Provider's Treatment Manual, Substance Abuse Service Hotline (SASH) and the Services and Bed Availability Tool (SBAT), as well as the applicability of 42 CFR Part 2 (Privacy, Confidentiality and exceptions thereto).



BILL TARKANIAN, B.A., J.D., L.A.A.D.C. is a recovering lawyer, and the Director of Program Development at the Los Angeles Centers for Alcohol & Drug Abuse (L.A. CADA).
